DR. HARRIET D. DARROW

Dr. Harriet D. Darrow's association with Indiana State University extends over 50 years as a student, educator, administrator, and leader. Retiring as emerita associate vice president for academic affairs and dean of instructional services, Darrow's first involvement with ISU was as an undergraduate student. Completing a bachelor of science in elementary education in 1954, she enrolled as a graduate student at ISU in 1955 and completed her master of science in 1956. Her third degree from ISU, a doctorate of education in elementary administration, was



completed in 1959. Two years later she earned a doctorate from Indiana University.

While completing her higher education degrees, Darrow was an instructor at the University's Laboratory School and an assistant professor in the Department of Education. From 1963 to 1967 Darrow taught in ISU's School of Education at the ranks of associate professor and professor.

As dean of summer sessions and academic services from 1967 to 1983, Darrow initiated, oversaw, and promoted a series of programs that ranged from summer school and extended services to the University's convocation series. Among programs she personally initiated were the Academic Services Program for Women, the Women's Finance Forum, and the High School Honors Program. Promoted to the associate vice president and dean position in 1983, she continued to lead the Division of Instructional Services until her retirement in 1988.

An active member and leader of professional organizations, Darrow held membership in the National Education Association, the Indiana State Teachers Association, the National Association of Summer Sessions, the National University Continuing Education Association, and Delta Kappa Gamma Society International, among others. She served as president of the North Central Conference on Summer Sessions in 1971-1972, and as president of the National Association of Summer Sessions in 1972-1973. Other services to the field of education

included the Indiana Committee for the Humanities and the Continuing Education for Indiana Higher Education Telecommunication Systems.

During her years at ISU Darrow was an active member on a variety of University committees both academic and student-oriented from research and admissions and academic standards to Greek affairs and student affairs. In addition, she was a member of the Alumni Advisory Council and served as a speaker at various alumni clubs throughout the state and nation.

Darrow also made numerous contributions to the Terre Haute and Wabash Valley communities. She served two terms as a member of the Board of Directors of the Vigo County Chamber of Commerce and was a member of the group's Public Relations Council, was a member of the Board of the Vigo County Cancer Society, and a board member of Leadership Terre Haute. In addition, she served on the boards of the United Way, the YWCA, and Regional Hospital.

In recognition of her years of service and leadership, Darrow has been the recipient of numerous honors. As a charter member of Delta Kappa Gamma Sorority, she was elected as the state second vice president in 1967 and the local chapter's president in 1971-1972. In 1973 she received commendation from ISU's Women's Faculty Club for her initiative with the Academic Services for Women Program. Darrow was selected as recipient of the Ursa Major Award by Alpha Phi sorority and as the Outstanding Alumnus by the ISU Panhellenic in 1976. In 1975, she received a national American Cancer Award for her service to the local organization. The Terre Haute Chamber of Commerce presented her with the Terre Award for Education in 1987. Darrow has also been listed in Who's Who in American Women, The World's Who's Who of Women, Personalities of the West and Midwest, and, since 1971, in Outstanding Educators of America.

Harriet and her husband, Dr. Norman L. Darrow, currently live in Rio Rancho, New Mexico near their son, Dr. Gregory Darrow who is a doctor of medicine.

EDWIN A. HILL

Vice president of human resources for Janssen Pharmaceutica, Inc., Edwin A. Hill believes in making things happen. It is this belief that has guided his career in human resources since his graduation from Indiana State University. A 1973 graduate with a bachelor of science degree in advertising/design and education, Hill served as a placement consultant at ISU until 1975 when he accepted a position at RCA Records/ Consumer Electronics as manager of employment and personnel records.



From 1975 to 1984, while working toward a masters degree in business administration at Indiana Central

University, Hill remained with RCA and its human resource division. During that time he held positions in the company's Indianapolis office as industrial relations specialist; manager of labor relations, compensation, and employment; and, eventually, manager of salary administration overseeing a staff of up to 25 staff members who were responsible for the salaries of 30,000 employees nationally and internationally.

In 1985, Hill accepted a position as manager of employee relations programs and communications with GE American Communications, Inc. in Princeton, New Jersey. In that position, Hill managed all areas of human resources for 700 employees at 60 locations. During his time with GE his accomplishments included designing a new variable pay plan, negotiating a new three-year contract with workers, and development of a management awards program.

Hill's next position was as manager of employee relations at Ortho Pharmaceutical Corporation in Raritan, New Jersey. In 1989 he was promoted to the company's director of employee relations, and, in 1991, was named executive director, total quality management.

After two years in that role, Hill was hired to his current position with Janssen Pharmaceutica, a company of the Johnson & Johnson Company in New Brunswick, New Jersey. It is in this position that Hill's belief in "doing something" has reached its highest level of success. He

has led Janssen Pharmaceutica to ten consecutive AA/EEO Awards in competition against 26 other Johnson & Johnson companies, and has initiated strategic planning as a critical process for managing the Janssen business. Hill was also selected by Johnson & Johnson as the only human resources speaker at their first worldwide "INNOVATION" meeting.

In addition to earning degrees from ISU and Indiana Central, Hill has attended a number of programs to advance his human resource skills. Among these were programs at Duke University, Northwestern University, and the GE Crotonville-Advanced Human Resources Management Program. Hill also completed the OUTWARD BOUND-Sea Program Survival Course in 1986.

A member of the Pharmaceutical Manufacturers Association, Hill is also a member of the American Compensation Association and the American Management Association. He is also active in his local community with the area Chamber of Commerce and the Boys and Girls Club and his local church. Diagnosed with multiple myeloma in 1998 (a form of bone cancer), Hill received a bone marrow transplant. Since his recovery he has been active in support of the Multiple Myeloma Research Foundation along with other charities.

A native of Gary, Indiana, Hill and his wife Brenda, a registered nurse, now live in Newton, Pennsylvania. They are the parents of six children and have five grandchildren.

PAUL LO

A native of Taiwan, Paul Lo is a 1970 graduate of Indiana State University with a master of business administration degree. Today he is an internationally recognized banker and financier residing in Hong Kong.

Lo is a leading force and outspoken supporter of economic growth and international trade between China and the United States. He is well on his way to making this philosophy a reality in his position as chairman of the Far East National Bank, a position he has held since 1997. Lo is also chairman of Bank SinoPac of Taiwan and president and chief executive officer of SinoPac Holdings.




Prior to his current appointments, Lo held positions for 17 years with Citibank in New York, San Francisco, and Los Angeles. In 1986, he moved to Hong Kong to start his own finance company, investing in businesses in China ranging from shoes to petrochemicals. With the opening of Taiwan's banking system to private banks in 1992, Lo formed Bank SinoPac by raising \$400 million in capital. In the years since its founding, SinoPac has grown rapidly despite the financial crisis other Asian banks faced in the 1990s. Today, SinoPac has 44 branches throughout Taiwan, one in California, two offices in Hong Kong and Vietnam, a United States subsidiary bank, and a host of financial affiliates including securities and leasing companies.

Lo has been featured in several international, Asian, and American financial magazines including *Business Week*, *Euromoney*, *The Banker*, *Global Finance*, and *The Asset*. In 1999 he was selected as one of *Business Week's* 50 Stars of Asia.

DR. THOMAS L. E. C. MOORE

A nationally recognized early childhood consultant, author, and children's recording artist, Dr. Thomas L. E. C. Moore's sensitivity to the needs of people with less opportunities was instrumental in bringing him to Indiana State University to earn masters and doctoral degrees. Moore has combined his talents as a musician and early childhood education scholar to become an effective leader in the field of early childhood education.





child care in China; to teacher-traveling workshops in Nigeria, St. Croix, and Germany; to a solo recital at Carnegie Hall, Moore creates learning experiences that educate and encourage those who teach young children.

Moore has also been an educational consultant for the government of Rivers States, Nigeria, provided consultant services for the child development services division of the United States Army in Germany and Italy, and is a former coordinator of the North Carolina Head Start Collaboration Project.

A prolific writer, Moore's books include Humpty Dumpty Dumpty, a children's book, and Where is Thumbkin?, a resource book for teachers. He is one of SRA/McGraw-Hill's early childhood curriculum authors, and a columnist for Children and Families, the official magazine of the National Head Start Association, and a 2003 community columnist for the Charlotte Observer. Moore has written articles for Young Children, Early Childhood Today, and Child Care Information Exchange. He has been quoted in Parents Magazine, the Dallas Morning News, and the New York Daily News, and is scheduled to write the lead article for Early Childhood Today, a Scholastic publication.

Moore has directed a children's choir, hosted a children's television show, and performed with opera companies in North Carolina and New York City. He has also appeared as guest conductor of the Charlotte Pops Orchestra. In addition, he is the official musician for the National Head

Start Association. On Sundays, he works as a staff associate at Myers Park United Methodist Church and volunteers as music accompanist at Seigle Avenue Presbyterian Church.


He has produced eight educational recordings that are used in early childhood classrooms throughout the world. Some of his most requested are "Humpty, Dumpty," "I Am Special," "Rock 'n Roll Patacake," and "Dream for Children." Moore is featured in the NAEYC resource video, "Music Across the Curriculum."

His honors and awards include Charlotte JC's Young Man of the Year, the NAACP Humanitarian Award, and the Order of the Long Leaf Pine Award (North Carolina's most distinguished civilian award). However, his most prized honor is the "Angel Among Us" award, presented by a Laurinburg, North Carolina kindergarten to second grade class.

Moore holds a bachelor of music degree from the Manhattan School of Music. His degrees from Indiana State University include a masters in 1988 and a doctorate in 1991. After graduation he worked as an assistant professor of early childhood education at the University of Southern Mississippi, associate professor of child and family studies at Georgia Southern University, and coordinator of the North Carolina Head Start Collaboration Project. Currently president of Thomas Moore Enterprises, Inc., Moore resides in Charlotte, North Carolina.

MARK MORGAN

In the 25 plus years since graduating from Indiana State University with a bachelor of science degree in accounting, Mark Morgan has used his education, initiative, and work ethic to create a successful career in business finance. Currently vice president for finance supporting research for Pfizer, Morgan credits his experience at ISU for preparing him for the challenges he meets in his position with the world's largest pharmaceutical company.





learning" program to expand students' experiential learning experiences. He also served as a staff writer for the *Indiana Statesman*.

Following graduation in 1976, Morgan took an entry-level accountant position with a small automotive radiator manufacturer in Wisconsin. Morgan's career with the pharmaceutical industry began three years later when he became assistant operations controller for Sterling Drug in Bloomington, Illinois. In 1984 he accepted a position with S.C. Johnson Wax and, by 1989, had moved up to the position of manager of corporate general accounting. For the next 20 years, starting in the position of director of finance, Morgan has been employed and promoted by Pfizer to his current position as vice president. In the process, Morgan and his family have moved ten times to seven states and Germany. His experiences with Pfizer have included responsible roles in the company's acquisition of Warner-Lambert and Pharmacea—two of the largest mergers in history.

Today, Morgan is a recognized financial expert. He is author of three articles published in professional accounting journals, one of which received an award of excellence. Morgan is a frequent speaker at business conferences and symposiums including the Kelly School of Business at Indiana University, the Balanced Scorecard Forum at Harvard University, the University of Connecticut, and the Institute of Management Accountants National Conference in 2002. He has also

taught as an adjunct instructor at the university-level and served as a Pfizer Junior Achievement Sponsor.

Active also with young people and his community, Morgan has coached children's sports teams in baseball, soccer, and basketball, and led the local 13-year-old Cub Scouts unit for several years. In addition, he has led his church's congregation as a monitor and chaired the financial committee. At Pfizers he co-chairs a group who donates materials and performs 50 man-days per year of labor to help maintain Camp Horizons, an assisted living camp for mentally challenged individuals.

Morgan and his wife Jody have two sons and reside in Stonington, Connecticut.
